1	School running after easing of restrictions	4	3	12	<ul style="list-style-type: none"> <li>From the 24<sup>th</sup> February 2022, There is no longer a legal requirement for people with coronavirus (COVID-19) infection to self-isolate, however if staff and pupils/students have any of the <a href="#">main symptoms of COVID-19</a> or a positive test result, the public health advice is to stay at home and avoid contact with other people.</li> <li>Staff and pupils/students who have the main symptoms of COVID-19 should <a href="#">order a PCR test</a>. You are advised to stay at home and avoid contact with other people while you are waiting for the test result.</li> </ul> <p>Main Symptoms of COVID-19</p> <ul style="list-style-type: none"> <li>A new continuous cough</li> <li>A high temperature</li> <li>A loss of, or change in, your normal sense of taste or smell (anosmia)</li> </ul> <p><b>Working from Home</b></p> <ul style="list-style-type: none"> <li>As of the 19<sup>th</sup> January 2022, the government announced that it is no longer advising staff to work from home.</li> <li>People previously considered to be particularly vulnerable, clinically extremely vulnerable (CEV), and high or higher-risk <b>are not being advised to shield</b> again (any personal advice from a specialist or clinician on additional precautions to take should continue to be followed). <a href="#">Guidance on Shielding and Protecting Extremely Vulnerable Persons from COVID-19</a></li> </ul> <p><b>Ventilation</b></p> <ul style="list-style-type: none"> <li>Adequate ventilation is provided whilst students and staff are on site.</li> <li>Windows may be partially opened in conjunction with heating systems to maintain a comfortable balance.</li> <li>School will ensure any events held in the school i.e. plays etc will be in a location where ventilation is maximised.</li> <li>School has a supply of CO2 monitors so staff can quickly identify where ventilation requires improvement.</li> </ul> <p><b>What to do if you have COVID-19</b></p>	4	2	8

					<ul style="list-style-type: none"> <li>The most effective way to avoid passing on COVID-19 infection is to stay at home and avoid contact with other people.</li> </ul> <p>Staff should:</p> <ul style="list-style-type: none"> <li>not attend work. If staff are unable to work from home, consultation will take place about options available.</li> <li>if you can, let people who you have been in close contact with know about your positive test result so that they can follow this guidance</li> </ul> <ul style="list-style-type: none"> <li>Staff may choose to take an LFD test from 5 days after symptoms started (or the day the test was taken if they did not have symptoms) followed by another LFD test the next day. If both these test results are negative, and the individual does not have a high temperature, the risk that they are still infectious is much lower and they can safely return to their normal routine. If the day 5 LFD test result is positive, continue taking LFD tests until 2 consecutive negative test results.</li> <li>*Children and young people with COVID-19 should not attend their education setting while they are infectious. They should take an LFD test from 5 days after their symptoms started (or the day their test was taken if they did not have symptoms) followed by another one the next day. If both these tests results are negative, they should return to their educational setting if they normally attend one, as long as they feel well enough to do so and do not have a temperature. <i>Where vulnerable pupils/students are self-isolating, it is very important that school has systems in place to keep in contact with them, particularly if they have a social worker. School should seek to support any pupils/students who they believe may have challenging circumstances at home</i></li> </ul> <p>The School will:</p> <ol style="list-style-type: none"> <li>Ensure good hygiene for everyone (hand and respiratory - which should now be regular practice)</li> <li>Maintain appropriate cleaning regimes</li> <li>Keep occupied spaces well ventilated (using CO<sub>2</sub> monitors to identify where ventilation needs to be improved)</li> <li>Follow public health advice on testing, self-isolation and managing confirmed cases of COVID-19.</li> </ol>				<p>*If a parent or carer insists on a pupil/student attending school where they have a confirmed or suspected case of COVID-19, you can take the decision to refuse the pupil/student if, in your reasonable judgement, it is necessary to protect other pupils/students and staff from possible infection with COVID-19.</p>
